

TERMS AND CONDITIONS OF SALE AND TRAVEL

General Terms And Conditions Of Sale And Travel

- All vessels, sailings and itineraries are subject to change at the company's discretion for reasons of weather conditions, sea states and/or for operational requirements. Belaire Ferries will not be liable for any consequential losses or additional costs incurred as a result of cancellation or delays.
- 2. Tickets purchased for travel are non-refundable and non-exchangeable.
- 3. Every passenger traveling between **West Harbour** and Downtown
 Auckland must tag on with their AT HOP card or present a valid single
 trip paper ticket to staff before boarding. On board cash ticket sales for
 this route have been discontinued.
 - Auckland Transport ticket machines are located at the Hobsonville Marina (West Harbour) and the Downtown Ferry Terminal.
 - In the event that a single trip ticket or AT HOP card is lost, stolen or misplaced, then a replacement ticket must be purchased before the passenger can travel.
- 4. For passengers travelling to/from Rakino Island, all payments for Cash Tickets on board are to be made in New Zealand dollars and must include payment for any bank charges. Payment for Cash Tickets can be made by Cash, Eftpos, Visa and Mastercard where facilities permit. No cheques will be accepted.
- 5. The terms and conditions of Sale and Travel are subject to New Zealand Law. All tickets must be used in accordance with any conditions printed thereon and/or published at our points of sale. Cash Tickets will not be accepted if defaced or mutilated.
- 6. AT HOP cards are used subject to AT HOP Terms and Conditions.
- 7. The Master of the vessel reserves the right to refuse any person access on any sailing for any reason; including any person who is unruly in behaviour, unfit to travel, is likely to cause distress or discomfort to other passengers or has previously engaged in any unlawful activities affecting Belaire Ferries. The Master may also require any person to leave the vessel.
- 8. Passengers must follow crew instructions. Failure to do so may result in refusal of carriage.
- 9. The Master of the vessel has the right to refuse to carry any passengers they consider too young or not competent or fit to travel under any circumstances. Passengers under the age of 14 must be accompanied by a responsible person 14 years of age or older.
- 10.Carriage of items over and above the luggage allowance per passenger will be charged for or refused accordingly at the sole discretion of the Master of the vessel and subject to operational limits.
- 11. The Master of the vessel has the right to refuse entry onboard the vessel to any passenger carrying any plant or animal pest. The Master has the right to inspect the contents of any passenger's luggage or freight for any plant or animal pest on any service whose destination is part of the Department of Conservation's estate.
- 12. Smoking, Vaping and E-Cigarette use is not permitted on any of Belaire Ferries vessels.
- 13.It is an offence for passengers to discharge rubbish overboard or in the wharf areas. Persons breaching the bylaw risk prosecution and a maximum fine of \$500.
- 14.No unaccompanied luggage will be carried on any of our services.

AT HOP cards must be preloaded with applicable concessions to
receive the discount when using these cards. Identification via valid ID
or AT Mobile App is required.

Rakino Island Ferry Service

- On Rakino Island Ferry Services, High School and Tertiary Students
 qualify for concession cash ticket prices upon presentation of a valid
 student ID or identification via the AT Mobile App.
- For the purpose of accompanying luggage or children to Rakino, a
 reduced delivery fare is available. This fare only applies when travel to
 the island is followed by return travel on the next immediate sailing.

SuperGold Card

West Harbour Ferry Service

 SuperGold Card holders can travel for free on West Harbour ferry services when using an AT HOP card with a SuperGold concession loaded on to it. Free travel applies from 9am Monday to Friday.
 SuperGold AT HOP card must be tagged on at the wharf prior to departure.

Rakino Island Ferry Service

 There is no discount available for SuperGold Card holders on the Rakino Island Service. Adult tickets prices will apply.

Family Pass

Rakino Island Ferry Service

- These tickets are for a one-way journey.
- Maximum four people including a maximum of two adults.

Bikes

West Harbour Ferry Service

 Bikes are permitted on board at the sole discretion of the Master of the vessel and subject to operational limits.

Rakino Island Ferry Service

 Bikes are permitted on board at the sole discretion of the Master of the vessel and subject to operational limits. An oversized luggage fee will apply.

Domestic Animals

- Pets are permitted on Belaire Ferries at no additional charge.
- Specific animal pests, including rabbits, ferrets, and stoats are not permitted on board.
- Pets must be transported in well-ventilated, secure carriers with a
 waterproof bottom. The carrier should fit on your lap or under the seat.
 Larger dogs must be kept on a short lead and are limited to the back
 deck during the journey.
- Owners are responsible for their pets, which includes cleaning up any
 mess before disembarking and refraining from allowing them on the
 seats or tables.
- Unaccompanied children under 16 are not allowed to travel with pets.
- Disability assist dogs are welcome at any time on all services and are
 not limited to traveling in a carrier or the back deck. Other owners and
 their pets may be required to make adjustments if a disability assist dog
 boards to prevent distractions.
- The Master of the vessel has the right to insist that a cage-type muzzle be put on any dog that raises safety concerns. Likewise, if a pet poses a

- safety risk or nuisance to others, entry may be denied, or passengers may be asked to leave without entitlement to a refund.
- Please always follow the instructions of the crew.

Additional Luggage / Bulky Items / Dangerous Goods West Harbour Ferry Service

- Passengers are limited to one small piece of Carry-on luggage per passenger. Any pieces of luggage over this allowance will be regarded as additional luggage and will be treated accordingly.
- Carriage of freight and items over and above the luggage allowance per passenger will be carried at the sole discretion of the Master of the vessel and subject to operational limits.
- Belaire Ferries accepts no responsibility for a passenger's personal luggage which is under their care and control, and for which no fee has been charged.
- Dangerous goods must be declared to the Master of the vessel and will be carried at their sole discretion.

Rakino Island Ferry Service

- Passengers are limited to one piece of Carry-on luggage and one
 medium size suitcase (or equivalent) per passenger. Any pieces of
 luggage over this allowance will be regarded as additional luggage and
 will be charged for or refused accordingly.
- Carriage of items over and above the luggage allowance per passenger will be charged for or refused accordingly at the sole discretion of the Master of the vessel and subject to operational limits.
- Bulky items may be charged for or refused accordingly.
- Additional luggage will be charged per item(s) that is(are) the equivalent of a medium size suitcase.
- Belaire Ferries accepts no responsibility for a passenger's personal luggage which is under their care and control, and for which no fee has been charged. One piece of Carry-on luggage and one medium size suitcase (or equivalent) per passenger may be carried free of charge.
- Additional luggage that has been charged for is carried at Limited
 Carrier's Risk. Belaire Ferries liability for luggage that is under Belaire
 Ferries' care and control and for which a separate fee has been charged
 is limited to liability pursuant to the Contract and Commercial Law Act
 2017. The Act limits Belaire Ferries liability to \$2,000 per item.
 Passengers are advised to arrange their own insurance cover for
 amounts over \$2,000.
- No petrol or gas cylinders may be carried in personal luggage. Items
 with a fuel tank must be declared and the tank must be empty. Small
 LPG bottles (max 9kg), petrol cans (max 10 Litres), paint, batteries and
 other dangerous substances must be declared and stowed safely under
 the direction of the vessel crew. If in doubt declare the item to the
 Master of the vessel.
- Dangerous goods must be declared regardless of whether the container is full or empty.
- Dangerous goods must be clearly and correctly identified and labelled, and carried only in the original manufacturer's packaging or approved refillable containers. These containers must not be damaged or leaking. Batteries require terminals to be covered or capped.
- Dangerous goods are carried at the discretion of the Master and subject to vessel capability.

Carriage of Battery Powered Bikes and Scooters

Battery powered bicycles and scooters may be carried subject to the following terms:

- E-Bikes and E-Scooters are not to be charged or left in a powered state on board the vessel
- E-Bikes and E Scooters are to be stowed securely and be easily accessible by crew should the need arise.
- E-Bikes and E-Scooters are to be manufactured to meet a NZ or international technical standard, and not be modified outside of the original manufacturer's specifications.
- E-Bike / -Scooter batteries must be secured inside a housing and not be exposed in order to prevent accidental damage to the the battery.
- E-Bikes and E-Scooters must belong to the passenger (no commercially operated bikes or scooters may be carried)
- E-Bikes and E-Scooters are carried at the discretion of the Master and subject to vessel capability.
